B. GENERAL BUSINESS

B-1 Tour of Historical Alameda High School

Staff and committee toured Historical Alameda High School which is currently under construction through bond and state matched funds. Jesse Hacket, Lathrop Construction's Superintendent and Romer Panagauiton, DSA Inspector of Record led the tour.

B-2 Construction Projects Update

Senior Construction Project Manager Robbie Lyng presented a comprehensive update on ongoing bond construction projects. This presentation highlighted the following facilities:

- Historic Alameda High School (under construction for seismic mitigation & modernization, on schedule for 9/2019 completion)
- Encinal Junior and Senior High School (currently in DSA, preconstruction services have begun)
- Edison Elementary (project awarded April 2018, 99% of work completed in 2018)
- Haight Elementary School (currently in DSA, work to begin in 2019)
- Franklin Elementary (currently in DSA, work to begin in 2020)
- Paden Elementary (project awarded April 2018, 99% of work completed in 2018)
- Lincoln Middle School (currently in DSA, work to begin in 2019)
- Ruby Bridges Elementary (project awarded April 2018, 99% completed in 2018)
- Fencing for Earhart, Bay Farm and Otis (High St.) (currently in DSA, work to begin in 2019)

CBO Shariq Khan presented an overview of the high school consolidation committee and the potential impact Board action regarding the committee report could have on the Measure I Bond.

Committee members inquired as to how best keep the community informed on the bond work as a whole, particularly the renovation of Historical Alameda High School. Members recommended putting information in the Alameda Sun and Journal, press releases etc.

B-3 Expenditure Report for Fiscal Year 2017-2018

Priscilla Wong presented the expenditure report for FY 17-18. Committee again requested a reformat of this report. Committee would like to see budgeted amounts listed for each project.

B-4 Discussion of Annual Report and Report Card

Committee to review 2017-2018 annual report at next scheduled meeting for presentation to the Board in early 2019. Staff will create a draft report for the committee to review at its next scheduled meeting.

Chair Sherratt included a "report card" on tonight's agenda as a possible way for school site communities to become informed of the bond work at their site. Chair Sherratt's idea is that this could be sent by site principals. Committee reviewed and provided input, there was agreement in the idea but concerns with the format. Committee agreed to research this idea individually and bring back to the next meeting for further discussion.
