- Lincoln Middle School (Complete)
- Bay Farm School Modernization (in design)
- Fencing for Earhart, Bay Farm, Love, Lincoln and Otis (High St.) (Complete)
- Technology & Communications New phone systems & wireless (AHS, EHS, Lincoln, Wood, Bay Farm, Earhart, Franklin, Maya Lin, Edison, Paden, Haight, Otis, ASTI, Ruby Bridges, AOA/Chipman, Adult School, District Office Main Phone Distribution Center for all schools, WCDC/Island High at Longfellow)

The committee was provided several construction drawings and photographs of ongoing and completed work.

#### B-3 2018-2019 Unaudited Actuals (10 Mins/Information)

Budget Analyst Priscilla Wong presented the committee the 2018-2019 Unaudited Actuals. This report shows expenditures by site and by project for a total of \$37,055,363.65 for the 18-19 fiscal year with an ending fund balance of \$22,073,428.78. These expenditures will

be audited in the late winter and the final independent auditors report will be reviewed at the next committee meeting.

It was noted that the committee now has an opening for an at-large member due to the resignation of Kim Ondreck Carim. The District will advertise for this opening.
