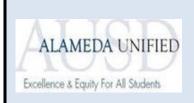

Professional development for the 2020-2021school year began with a four day Learning Summit dedicated to distance and hybrid learning through a culturally responsive lens. Teachers increased levels of familiarity with technology and educational applications that support standards-based learning. Grade level priority standards were identified and teachers collaborated to develop lessons and educational experiences that support student progress toward these standards.

In addition to the Learning Summit, Otis teachers analyze and review student work/data in regular professional communities. During these professional communities, teachers focus on planning for small group instruction and targeted support. Otis prioritizes equity and inclusion, therefore, we have dedicated monthly collaboration time for anti-racist, culturally and linguistically responsive work.
