2019-2020 Budget – Governor's Budget Proposal Themes for the 2019-20 Governor's Budget

- The economy continues to outperform expectations, but the recovery from the Great Recession is in its tenth year and some signs of downturn are appearing
- Local education agencies (LEAs) will continue to face budget challenges as Local Control Funding Formula (LCFF) funding flattens and costs rise
- The education budget contains some new proposals, but Governor Newsom's early childhood education initiative will take central stage

2019-2020 Budget – Governor's Budget Proposal Early Care and Education

- In total, the 2019-20 Budget includes over \$2.4 billion in programs and services to children and families
 - Most are one-time investments
 - Nearly all of them are funded with non-Proposition 98 dollars
- \$750M to expand or retrofit 1400 facilities to accommodate Full-Day Kindergarten
- AB197, if passed, may require that all schools must transition to Full-Day
 Kindergarten by offering same number of minutes per school day that is offered to
 students in 1st grade.
 - If passed, the bill is proposed to go into effect in 2021-22 school year

2019-2020 Budget – Governor's Budget Proposal Local Control Funding Formula

- The State Budget proposes \$2 billion towards LCFF to fund the 3.46% statutory COLA
 - COLA does not apply to Targeted Instructional Improvement Grant (TIIG),
 Transportation, or Economic Recovery Target, effectively reducing the COLA to approximately 3.37%

Proposed increase of approximately \$600K in 2019-20 and \$200K in 2020-21

2019-2020 Budget – Governor's Budget Proposal Pension Contributions

- \$3 billion in one-time, non-proposition 98 funding to reduce employer's liability
 - \$700M to reduce 2019-20 and 2020-21 by about 1%
 - \$2.3B to reduce it by approximately 0.5% in out years

Proposal would save approximately \$500K each year for the next two years

2019-2020 Budget – Governor's Budget Proposal Special Education

- No new funding proposal for Special Education AB 602 program
 - 3.46% proposed COLA or estimated \$18.67/ADA
 - District expenditures since First Interim have increased by approximately \$500K
- No additional funding to provide transportation to students with Special Education services, not even COLA!
- Governor proposed \$576M (of which \$186M is one-time) to support expanded Special Education services for Districts with high percentages of both students with disabilities (SWD) and unduplicated students
 - Funds may be used to provide supplemental services not currently provided in an IEP or for preventive services that may reduce the need for additional services in future years
