- Love Elementary School (Project awarded to Alten 3/12/19, work complete by October 2019)
- Franklin Elementary (DSA approved, work to begin in 2020)
- Lincoln Middle School (Project awarded to Lathrop 3/12/19, work complete November/December 2019)
- Bay Farm School Modernization (in design)
- Fencing for Earhart, Bay Farm, Love, Lincoln and Otis (High St.) (Project awarded to Lathrop 3/12/19, work complete 9/2019)
- Technology & Communications New phone systems & wireless (AHS, EHS, Lincoln, Wood, Bay Farm, Earhart, Franklin, Maya Lin, Edison, Paden, Haight, Otis, ASTI, Ruby Bridges, AOA/Chipman, Adult School, District Office Main Phone Distribution Center for all schools, WCDC/Island High at Longfellow)

The committee was provided several construction drawings and photographs of ongoing and completed work.

B-3 HAHS Grand Opening Ceremony Discussion (5 Mins/Information)

Historical Alameda High School work will be completed in September, 2019. The District is planning a large grand opening ceremony for the entire Alameda community to be held on Thursday, August 8 at 4:00pm.
